Director (Rolling Stock & Systems) will be responsible for overall Administration for all systems projects for Nagpur Metro Rail including planning, design and architecture, tendering, contracting and, supervision of construction and Commissioning of the Rolling Stock, Traction, signalling & telecommunication, electromechanical works of station or depots & other buildings and all other electrical works pertaining to metro construction including utility shifting. He will also be responsible for project monitoring, interface management, quality assurance safety & cost control for the above systems.

B. ESSENTIALS:

- i. Degree in Electrical / or Degree in Electronics Engineering from an institution of repute.
