7. **Successful service provider shall not have any claim upon the quoted amount & deployment /engagement of number of vehicle proposed in the above BOQ. The number of vehicles proposed in the BOQ is tentative & deployment / engagement of vehicle shall be as per requirement & discretion of Maha-Metro (Nagpur Metro Rail Project)**
8. Successful Service Provider shall arrange proper & adequate insurance cover to all his assets, people and staff engaged in the execution of work (including the third party) at his own cost.
9. The services to be provided by the successful bidder shall be for 10 hours and up to limit of Kms as stated in BOQ above under each type of vehicle. The Extra hours of Services & Distance (KM) shall be paid on pro-rata basis.
