SECTION - 2**ELIGIBILITY CRITERIA****3.1 Eligible Bidders: -**

- 3.1.1** The bidder should have Statutory registration like shop act / company act / incorporation certificate, etc. issued by any Government Authority.
- 3.1.2 GST and Income Tax Registration:** - The bidder must have a valid **GST** and Income Tax registration under the relevant acts.

- 1. The offers submitted without these documentary proof shall not be evaluated and therefore their tenders will be rejected.**

SECTION- 3 SCOPE OF WORK

Name of work: Disposal by sale of old unusable material at Kharghar Metro Station (Station – 06) of Navi Mumbai Metro Line-1.

1. **Completion period:** 10 days from the date of issue of Bid Acceptance Letter

2. **Scope of work:**

Maha Metro has been awarded with the Project of balance works of Navi Mumbai Metro Rail Project – Line 1 at Navi Mumbai on 23rd February 2021.

The old unusable previous contractor materials of PEB structure steel and other materials such GI shed, HDPE pipes of previous contractors are stacked at Kharghar Metro Station (Station-06) of NMML-1, which are obstructing the construction activities and ground development works. The disposal of these scrap items from the site is to be done on the basis of AS IS WHERE IS WHAT IS. The material to be sold through this tender will be stacked separately at the Maha-Metro's site and the area will be demarked with unique identification.

The weight of the said M.S. material comprising of trusses and supporting beams is approximately 100 tonnes (liable to change upwards/downwards), estimated through visual judgement only.

The scope of work of the bidder includes disposal of the scrap materials stacked at Kharghar Metro Station (Station-06), its cutting and dismantling if required, loading / unloading, transportation, manpower, machineries etc. The arrangement of Government authenticated Electronic weigh bridge for weighing of scrap materials will be the responsibility of the bidder at no extra cost.

It is the responsibility of the bidder to visit the site and to inspect and satisfy themselves about the unserviceable/scrap materials before participating in the bid. The scrap materials for sale can be inspected by interested bidders on all working day during office hours by contacting the Maharashtra Metro Rail Corporation Ltd., Navi Mumbai Office up to day prior to last date of bid submission.

Required road & levelling to the spot shall have to be arranged by the successful bidder on its own. The work shall be near station area and all the necessary permission shall be taken by the successful bidder before start of work.

The Successful bidder will have to make his own arrangement for loading and transport and will not be entitled to claim any facilities or assistance either for loading or for transport from the location where scrap materials are laying i.e. Kharghar metro Station (Station 6) of Navi Mumbai Metro Line-1. In case the successful bidder fails to deposit the bid amount and the caution deposit within the stipulated time, Maha-Metro will be at liberty to forfeit the EMD.

3. Special Condition of Contract:**a. Mode of Measurement: Per Tonne**

The bid shall be confirmed in favour of bidder who offers the highest rate per tonne in his bid. The quantity of offered items is on assessment basis it may vary subject to availability at the Site. The total amount to be deposited by the highest bidder will depend on the actual quantities of scrap materials available on site (Kharghar Metro Station) assessed in the Government authenticated Electronic weigh bridge.

b. System of Measurement:

Each truck before loading shall be kept empty and loaded in the weighment. The Weighment should be checked in the Government authenticated Electronic weigh bridge accompanied by the representative of the Maha-Metro and bidder for certification of the weighment. The weighment slips shall be produced/surrendered to the Maha-Metro Representative for the accountability and record.

- c. The successful bidder shall remit full amount quoted by him +20% Over and above the amount quoted as a caution deposit and will be allowed to remove the material upto the magnitude of the amount deposited by him and by adjusting accordingly to the weighment slip of scrap materials lifted by the bidder. Subsequently on completion of the removal of materials upto the deposited value, if there is balance scrap material on site, the bidder shall be allowed to lift the balance materials on payment of further amount in advance as directed by Maha-Metro authorities on assessment of the balance quantity of materials left on site for disposal.
- d. If the total quantity of scrap materials available on site is less than 100 tonnes the amount equivalent to the excess scrap materials deposited by the successful bidder alongwith the caution deposit will be refunded to the successful bidder.
- e. The successful tenderer will have to deposit the entire amount of the sale order in Indian Rupees on the basis of accepted price/rate in one instalment within 7 (seven) days from the date of issue of Bid Acceptance Letter. On failure of the successful bidder in paying the bid amount in the stipulated time (7 days), the bid will stand cancelled and entire deposit amount paid by the bidder (EMD as well as Security Deposit) shall be forfeited without any notice and scrap materials will be resold.
- f. The offered material/scrap shall be lifted by the bidder from the Kharghar Metro Station of Navi Mumbai Metro Line-1 within convenient time as mutually decided by Maha-Metro's In charge and bidder/their representative according to feasibility/site condition. Removal of scrap materials is allowed only after proper weighing of materials/scrap by/in the presence Maha-Metro official.
- g. No items, once disposed of, from the successful bidder shall be taken back by this office on any condition whatsoever. Any uncleared or unnoticed materials left over by the purchaser within the premises cannot be claimed later.
- h. The bidder should conduct due diligence on all aspects related to the scrap materials to his satisfaction. The bidder shall not be entitled to make any claim against the Authorised Officer in this regard at a later date.

- i. It shall be at the discretion of the Authorized committee / Officer to cancel bid proceedings without assigning any reason thereof and return EMD submitted. The EMD will not carry any interest.
- j. Maha-Metro reserves the right to reject any or all offer/bids for the said sale without assigning any reason thereof.
- k. The purchase price shall be quoted in figure and words, in the schedule enclosed and in case of any discrepancy in price quoted in figures and words, the price written in words shall prevail.
- l. Conditional tenders will be rejected.
- m. The materials should be cleared away from the designated location within 15 days from the date of issue of bid acceptance letter. There should not be any damage to the properties of this office/ inconvenience in functioning.
- n. Obtaining all statutory approvals from the Local Bodies/Police/traffic wing required for purchase, Loading/Unloading/clearing or transportation of materials is the sole responsibility of the purchaser only. Maha-Metro cannot be held responsible for any delay or lapses in this regard.
- o. For the purpose of removing the materials, the bidder shall engage his/their own personnel only and shall keep Maha-Metro fully indemnified against any claim whatsoever including for wage, injuries, compensation, death etc.
- p. The successful bidder should bear the charges/fees payable for conveyance such as Stamp Duty, Registration Fees, Taxes, Cost of expenses etc as applicable as per law. The Successful bidder shall also bear all statutory dues, if any.
- q. The entire amount paid by the bidder shall be liable for forfeiture without prior notice, if the successful bidder fails to adhere to the terms and conditions of the Sale.

SECTION -4
CONDITIONS OF CONTRACT

1. Earnest Money Deposit:

All bidders/tenderers should submit their bid along with the Earnest Money Deposit (EMD) by paying Maha-Metro INR 24,000/- through the payment method mentioned in the NIT. Earnest Money Deposit (EMD) will be refundable to the unsuccessful bidders after award of the work.

The EMD of the successful bidder shall be retained and will be returned after submitting the Demand Draft of the full amount as quoted in the bid plus the caution deposit. The successful bidder can opt to adjust the paid EMD towards the security deposit and pay the balance security deposit after issue of the LOA.

No tenders shall be accepted/entertained without earnest money deposit.

2. SECURITY DEPOSIT CUM CAUTION DEPOSIT

a) Already mentioned in para b) of PAYMENT TERMS below.

3. CONTRACT COMPLETION PERIOD & EOT:

a) The completion period for said work shall be 10 days from the date specified in LOA.

b) For any unforeseen reason, the work is delayed on MAHA-METRO account, then suitable extension to the completion period shall be granted without liquidated damages.

4. PAYMENT TERMS:

a) The quote invited against this tender is exclusive of GST.

b) The successful bidder shall submit full amount quoted by him +20% Over and above the amount quoted as a caution deposit in the form of Demand Draft (DD) in favour of ***“Maharashtra Metro Rail Corporation Limited”***.

c) GST shall be mentioned separately in the GST invoice at the time of billing as per prevailing rules of act of Govt. of India and Govt. of Maharashtra and the successful bidder shall pay the billed amount accordingly.

5. CHANGES IN SCOPE OF WORK

MAHA METRO shall have the right to propose and make any change, modification, de-scoping, addition, or deletion to, in, or from the scope of work (interchangeably called “Change”), provided that such Change falls within the general scope of work, does not constitute unrelated work, and is technically practicable, taking into account both the state of advancement of the work and the technical compatibility of the Change envisaged with the nature of the project as originally specified in the Contract.

6. VARIATION & QUANTITIES

The quantities provided in Financial Bid (Section-08) is provisional and may vary up to 25% (+/-) both ways. The contractor shall execute the contract on accepted rate irrespective of quantum of variation. In case the negative variation the payment shall be made for an actual quantity executed with Maha-Metro. No compensation is payable to the contractor in case of a reduction in quantity availed by Maha-Metro. Payment shall be made as per actual quantity availed by Maha-Metro upon certification of officials of Maha-Metro.

7. PRICE VARIATION

The accepted rate shall be fixed and no price variation shall be applicable in this contract during the entire period of the contract.

8. INSURANCE

- a. Successful bidder must obtain adequate insurance against damage to third party (Injury to any person/Damage to Property/Loss of life of any person) due to this work. Maha-Metro will not entertain any claims if the situation arises due to the same nor it shall be liable to make a party before the law.
- b. All medical expenses / compensation towards the sickness / disability of personal shall be arranged by successful bidder at his own expenses.

9. TAXES AND DUTIES:

- (a) Amount quoted by bidder shall be inclusive of all other taxes, duties, cess, levies payables etc. **but excluding GST.**
- (b) The Contract Price is inclusive of all other taxes, leviables, Transportation charges, loading & unloading, handling, labour charges, unforeseen expanses complete all etc but excluding applicable GST. GST shall be mentioned separately in the GST invoice at the time of billing as per prevailing rules of act of Govt. of India and Govt. of Maharashtra and the Contractor shall pay the same against the raised invoice.

10. TERMINATION OF THE CONTRACT:

- (a) In case of any material violation (As described in Section-8, Financial Bid) of any of the terms and conditions by the contractor, the MAHA-METRO reserves its right to unilaterally terminate the contract.
- (b) The contract may be terminated before the contract period owing to deficiency in service or substandard quality of manpower deployed by the selected contractor or cessation of the requirement of work. MAHA-METRO, however, reserves the right to terminate this initial contract at any time after giving one month's notice to the selected service providing firm/company.
- (c) Indulgence of unethical / unlawful activity, not following the basic hygiene in offices & site offices, indiscipline / rude behaviors of staff deployed by contractor and repetition of such incidents three times may lead to termination of contract, if Contractor fails to replace such unruly personals.

(d) MAHA-METRO (NAGPUR) reserves right to terminate the contract at any point of time after giving a one-month notice to the contractor in case of cessations of requirement of such services.

11. SECURITY & CHARACTER CONSIDERATIONS

The people deployed by the Contractor should not have any Police record/criminal cases against them. The Contractor should make adequate enquiries about the character and antecedents of the persons whom they are deploying at Maha-Metro premises.

12. PUNCTUALITY & DISCIPLINE

- (a) MAHA-METRO shall not be liable for any loss, damage, theft, burglary or robbery of any personal belongings, equipment or vehicles of the personnel of the Contractor.
- (b) The Contractor will be responsible for any damages done to the property of MAHA-METRO by the personnel so employed. MAHA-METRO will be free to recover it from the security deposit given by the Contractor or from any other dues.
- (c) The Contractor shall be responsible for any act of indiscipline on the part of persons deployed by him.
- (d) The Contractor shall be contactable at all times and message sent by email/Fax/Special Messages from MAHA-METRO to the Contractor shall be acknowledged immediately.
- (e) The Contractor shall not assign, transfer, pledge or sub-contract the performance or service without the prior written consent of MAHA-METRO.

13. APPLICABLE LAW

Indian Contract Act 1872 and its further amendments. Governed by the laws and procedures established by Government of India, within the frame-work of applicable legislations and enactments made from time to time concerning such techno commercial dealings/processing.

14. JURISDICTION OF COURT

In case of any dispute which is remains unresolved by mutual negotiation or ADR method, the decision of court in the jurisdiction of **Nagpur Bench of High Court of Bombay** shall be binding and final. The **Judicature of Nagpur Bench of High Court of Bombay** shall have the exclusive jurisdiction to try all dispute arising out of this work between the parties
