3. **Submission of Bid Documents**: The bids documents should be submitted in the office of NMRCL in the address mentioned in **Sr. No. 7** of this Notice from **11.05.2015** to **12:00 Noon** on **18.05.2015** (Excluding Holiday and Sundays, if any) with all documents required in accordance with ITB 8 of bid documents.

4. Bids must be accompanied by a bid security of **Rs. 40,00,000/- (Rupees Forty lakhs only)** in the form as specified in the bidding documents and shall have to be valid for **120 days** beyond the validity of the bid.

NMRCL will not be responsible for any delays in receiving the Bidding documents by the Bidder. Bids received by the post shall not be entertained /considered and shall be liable for rejection, outright.
